#### **SUMMARY ORDER**

(Pursuant to K.S.A. 2002 Supp. 40-4909 and K.S.A. 77-537)

Pursuant to authority granted to the Commissioner of Insurance ("Commissioner") by K.S.A. 2002 Supp. 40-4909, the Commissioner hereby revokes the nonresident agent's license of Ruby Lopez ("Lopez") by way of Summary Order as provided by K.S.A. 77-537.

### **Findings of Fact**

The Commissioner has been shown the following facts:

- 1. Records maintained by the Kansas Insurance Department ("KID") indicate that Lopez is licensed as a nonresident agent to transact the business of insurance in the State of Kansas. KID records further indicate a legal of 2314 Chapel Hill Circle, Stockton, CA 95209, and a mailing address of 6221 N. West Lane, Stockton, CA 95210.
- 2. The National Association of Insurance Commissioners ("NAIC") Regulatory Information Retrieval System ("RIRS") database reflects the following information: The State of California revoked Lopez' resident insurance agent's license, effective February 19, 2003, because of "criminal record/history."
  - 3. To date, this action has not been reported to the KID.
- 4. By letters dated March 25, 2003, mailed to the legal address, and April 17, 2003, mailed to the mailing address, KID requested that Lopez provide details of the California action.
- 5. In the April 17 letter, Lopez was advised that if she did not respond by May 1, 2003, action would be taken to revoke her Kansas license.

6. To date, the letters have not been returned, and Lopez has not responded to the KID inquiries.

## **Applicable Law**

7. K.S.A. 2002 Supp. 40-4909(a) provides, in relevant part:

"The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has . . . (2) Violated: (A) Any provision of chapter 40 of the Kansas Statutes Annotated, and amendments thereto, or any rule and regulation promulgated thereunder; (B) Any subpoena or order of the commissioner . . . (9) Had an insurance agent license, or its equivalent, denied, suspended or revoked in any other state, district or territory." K.S.A. 2002 Supp. 40-4909(a).

- 8. Administrative regulations require that a person licensed in this state as an insurance agent shall, within 30 days of the occurrence, report enumerated events to the Commissioner. Among these events are disciplinary actions against the agent's license by the insurance regulatory official of any other state or territory. K.A.R. § 40-7-9.
- 9. K.S.A. 2002 Supp. 40-4906 and 4908 provide for issuance of a nonresident agent's license in reliance upon the agent's valid license in the agent's home state.
- 10. The Commissioner may revoke any license issued under the Insurance Agents Licensing Act if the Commissioner finds that the insurable interests of the public are not properly served under such license. K.S.A. 2002 Supp. 40-4909(b).

#### **Conclusions of Law**

- 11. The Commissioner has jurisdiction over Lopez as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
- 12. The Commissioner finds that Lopez' Kansas license may be revoked solely because Lopez has had a license revoked in another state.

- 13. Lopez' Kansas nonresident insurance agent's license is based on reciprocity with the State of California and issued in reliance upon California licensing standards.
- 14. The Commissioner concludes that Lopez is no longer entitled to hold a license based on reciprocity because the California license has been revoked.
- 15. The Commissioner further finds that Lopez violated the administrative regulation requiring a licensed agent to report disciplinary action by other states within 30 days.
- 16. The Commissioner finds that Lopez failed to respond to the inquiries regarding the California action despite having been advised that failure to respond would result in action to revoke her Kansas license.
- 17. Accordingly, the Commissioner concludes that sufficient grounds exist for the revocation of the insurance agent's license of Ruby Lopez pursuant to K.S.A. 2002 Supp. 40-4909(a).
- 18. Moreover, the Commissioner finds that Lopez' insurance agent's license should be revoked pursuant to K.S.A. 2002 Supp. 40-4909(b) for the protection of the insurable interests of the public.
- 19. Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of the law and the protection of the public interest does not require the KID to give notice and opportunity to participate to persons other than Ruby Lopez.

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE
THAT the Kansas resident insurance agent's license of Ruby Lopez is hereby **REVOKED**.

#### **Notice and Opportunity for Hearing**

Ruby Lopez within fifteen (15) days of service of this Summary Order, may file with the KID written request for a hearing on this Summary Order, as provided by K.S.A. 77-542. In the event a hearing is requested, such request should be directed to John W. Campbell, General Counsel, Kansas Insurance Department, 420 S.W. 9<sup>th</sup> Street, Topeka, KS 66612.

Any costs incurred as a result of conducting any administrative hearing shall be assessed against the agent who is the subject of the hearing as provided by K.S.A. 40-4909(f). Costs shall include witness fees, mileage allowances, any costs associated with the reproduction of documents which become part of the hearing record, and the expense of making a record of the hearing.

If a hearing is not requested, this summary order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen-day period for requesting a hearing.

The Final Order will constitute final agency action in this matter.
