SUMMARY ORDER

(Pursuant to K.S.A. 40-955 and K.S.A. 40-2,125)

Pursuant to the authority conferred on the Commissioner of Insurance by K.S.A. 40-955 and K.S.A. 40-2,125 and by invoking K.S.A. 77-537, the Commissioner hereby admonishes and assesses penalty against United Services Automobile Association ("USAA") for violation of the applicable Kansas insurance code.

Findings of Fact

- United Services Automobile Association ("USAA") of San Antonio, Texas, located at 9800 Fredricksburg Rd., San Antonio, Texas 78288, has been authorized to transact and continuously engaged in transacting insurance business in the State of Kansas since December 31, 1962.
- 2. On October 25, 2006 USAA submitted a SERFF filing for approval by the Kansas Insurance Department ("KID").
- USAA requested an effective date and an implementation date of September 1, 2006 for the SERFF filing.
- Pursuant to a telephone conversation with Debra Guevara, Compliance Analyst, for USAA it was determined the Tier Redefinition filing was implemented by USAA on September 1, 2006.
- 5. The USAA SERFF filing was approved by KID on November 15, 2006.

Applicable Law

K.S.A. 40-955 states, in pertinent part:

- (a) Every insurer shall file with the commissioner every manual of classifications, rules and rates, every rating plan, policy form and every modification of any of the foregoing which it proposes to use. Every filing shall indicate the proposed effective date and the character and extent of the coverage contemplated and shall be accompanied by the information upon which the insurer supports the filings. A filing and any supporting information shall be open to public inspection after it is filed with the commissioner.
- (b) Any other rate filing, except personal lines filings, shall become effective on filing or any prospective date selected by the insurer, subject to the commissioner disapproving the same if the rates are determined to be inadequate, excessive, unfairly discriminatory, or otherwise fails to meet the requirements of this act. Personal lines rate filing shall be on file for a waiting period of 30 days before becoming effective, subject to the commissioner disapproving the same if the rates are determined to be inadequate, excessive, unfairly discriminatory or otherwise fail to meet the requirements of this act. The term "personal lines" shall mean insurance for noncommercial automobile, homeowners, dwelling fire-and-renters insurance policies, as defined by rules and regulations. A filing complies with this act unless it is disapproved by the commissioner within the waiting period or pursuant to subsection (e).

K.S.A. 40-2,125 authorizes:

- (a) If the commissioner determines after notice and opportunity for a hearing that a person has engaged or is engaged in any act or practice constituting a violation of any provision of the Kansas insurance statutes or any rule and regulation or order thereunder, the commissioner may in the exercise of discretion, order any one or more of the following:
 - (1) Payment of a monetary penalty of not more than \$1,000 for each and every act or violation, unless the person knew or should have know such person was in violation of the Kansas insurance statutes or any rule and regulation or order thereunder, in which case the penalty shall be not more than \$2,000 for each and every act or violation.

Conclusions of Law

Based on the Findings of Fact enumerated in Paragraphs #1 through #5 and the Applicable Law, **THE COMMISSIONER OF INSURANCE FINDS:**

- On October 25, 2006 United Services Automobile Association ("USAA") submitted a SERFF filing for approval by the Kansas Insurance Department ("KID").
- USAA requested an effective date and an implementation date of September 1, 2006 for the SERFF filing.
- Pursuant to a telephone conversation with Debra Guevara, Compliance Analyst for USAA, it was determined the Tier Redefinition filing was implemented by USAA on September 1, 2006.
- 4. KID did not approve the SERFF filing until November 15, 2006.
- 5. USAA's implementation of the Tier Redefinition prior to receiving KID approval constitutes a violation of K.S.A. 40-955.

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE:

USAA's actions in implementing the Tier Redefinition on September 1, 2006 prior to receiving approval via a SERFF filing constitutes a violation of K.S.A. 40-955. Therefore, USAA shall pay a monetary penalty of One Thousand Dollars and no cents (\$1,000.00), due and payable to the Kansas Insurance Commissioner on or before the 14th day from the date of this Order.

NOTICE OF RIGHTS

United Services Automobile Association ("USAA") is entitled to a hearing pursuant to K.S.A. 77-537, the Kansas Administrative Procedure Act. If USAA desires a hearing, it must file a written request for hearing with:

If USAA requests a hearing, the Kansas Insurance Department will notify the same of the time and place of the hearing and information on the procedures, rights of representation, and other rights of parties relating to the conduct of the hearing, before commencement of the hearing.

If a hearing is not requested in the time and manner stated above, this Summary Order shall become effective as a Final Order upon the expiration of time for requesting a hearing, pursuant to K.S.A. 77-613. In the event USAA files a petition for judicial review, pursuant to K.S.A. 77-613(e), the agency officer to be served on behalf of the Kansas Insurance Department is:
