SUMMARY ORDER (Pursuant to K.S.A. 40-4909 and K.S.A. 77-537)

Pursuant to authority granted to the Commissioner of Insurance ("Commissioner") by K.S.A. 40-4909, the Commissioner hereby proposes to find facts and revoke the Kansas nonresident insurance agent's license of Jane M. Owens ("Respondent") by way of Summary Order as provided by K.S.A. 77-537.

Findings of Fact

1. Records maintained by the Kansas Insurance Department ("KID") reflect that Respondent is licensed as a nonresident agent to transact the business of insurance in Kansas and has been so licensed since June 17, 2009

2. KID records further indicate Respondent's legal and mailing address is 916 Fairway Lane, Soddy Daisy, TN 37379-4520.

3. Following investigation, the Commissioner has no reason to believe that protection of the public interest requires the Commissioner to give notice and opportunity to participate to anyone other than the respondent.

4. Following investigation, the Commissioner finds evidence sufficient to support the following findings of fact:

5. Effective January 14, 2011, Respondent's Tennessee insurance producer license was revoked.

6. Respondent did not report this action to the Commissioner within 30 days as required by K.A.R. §40-7-9(a) and has not reported it to date.

7. By letter of April 20, 2011, counsel for KID wrote to Respondent at her mailing address of record and invited Respondent to reply within 15 business days if she disputed the above.

8. On May 5, 2011, Respondent requested cancellation of her Kansas license but did not provide the Tennessee order.

9. KID subsequently obtained a copy of the Tennessee Consent Order, docket number 10-049.

10. The Consent Order reflects that Respondent assisted the principals of her

agency in a scheme to defraud clients of undisclosed commissions and fees by altering

insurance documents and is permanently barred from any business for which a license

is required by Tennessee law.

Applicable Law

11. K.S.A. 2010 Supp. 40-4909(a) provides, in relevant part:

"The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has: . . .

(2) Violated: (A) Any provision of chapter 40 of the Kansas Statutes Annotated, and amendments thereto, or any rule and regulation promulgated thereunder; . . .

(5) Intentionally misrepresented the provisions, terms and conditions of an actual or proposed insurance contract or application for insurance....

(8) Used any fraudulent, coercive, or dishonest practice, or demonstrated any incompetence, untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere. (9) Had an insurance agent license, or its equivalent, denied, suspended or revoked in any other state, district or territory." K.S.A. 2010 Supp. 40-4909(a).

12. K.A.R. §40-7-9 requires a licensed agent to report to the Commissioner within 30 days any disciplinary action against the agent's license by the insurance regulatory agency of another jurisdiction or any criminal conviction.

13. In addition, the Commissioner may revoke any license issued under the Insurance Agents Licensing Act if the Commissioner finds that the interests of the insurer or the insurable interests of the public are not properly served under such license. K.S.A. 2010 Supp. 40-4909(b).

14. Voluntary surrender of a license does not deprive the Commissioner of jurisdiction to institute or proceed with an action against the license to render a decision or make a record of the facts. K.S.A. 2010 Supp. 40-4909(e).

Conclusions of Law

15. The Commissioner has jurisdiction over Respondent as well as the subject matter of this proceeding, and such proceeding is held in the public interest.

16. The Commissioner finds, based on the facts contained in paragraphs 5 through 10, that Respondent's license may be revoked pursuant to K.S.A. 40-4909(a)(2)(A) because Respondent has violated K.A.R. §40-7-9 by failing to report a disciplinary action against her insurance agent license by another state.

17. The Commissioner finds based on the findings contained in the Tennessee Consent Order that Respondent's license may be revoked pursuant to K.S.A. 40-4909(a)(5) and/or (a)(8).

18. The Commissioner finds that Respondent's license may be revoked pursuant to K.S.A. 40-4909(a)(8) because Respondent has a license revoked or suspended by other states.

19. Based on the foregoing findings, the Commissioner concludes that sufficient grounds exist for the revocation of Respondent's insurance agent's license pursuant to K.S.A. 40-4909(a).

20. The Commissioner further concludes Respondent's license may be revoked pursuant to K.S.A. 40-4909(b) because such license is not properly serving the interests of the insurer and the insurable interests of the public.

21. Despite Respondent's surrender of the license, the Commissioner retains jurisdiction to revoke the license for the purpose of making a record.

22. Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of the law, the protection of the public interest does not require the KID to give notice and opportunity to participate to persons other than Respondent, and after investigation, KID believes in good faith that the allegations will be supported to the applicable standard of proof.

Policy to be Served

23. Before issuing an insurance agent license, the Commissioner must determine that the applicant is qualified and has not committed any act that would be grounds for denial, suspension, or revocation. K.S.A. 40-4905(b). Further, the Commissioner may revoke any license issued under the Insurance Agents Licensing Act if the

Commissioner finds that the interests of the insurer or the insurable interests of the public are not properly served under the license. The following action is appropriate to promote the security and integrity of the insurance business and protect insurance consumers by licensing, or continuing to license, persons or entities to sell, solicit, or negotiate insurance in the State of Kansas only if their conduct indicates they are both qualified and trustworthy.

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT the Kansas nonresident insurance agent's license of JANE M. OWENS is hereby **REVOKED.** It is further ordered, that JANE M. OWENS shall CEASE and DESIST from the sale, solicitation, or negotiation of insurance, doing any act toward the sale, solicitation, or negotiation of insurance, and/or receiving compensation deriving from the sale, solicitation, or negotiation of insurance conducted on and after the effective date of this order.
